### Parental Consent Form

#### *Terms & Conditions*

For insurance reasons, all HELL & BACK Junior participants must have parental/guardian permission to take part in the event.

#### **Age of Participant**

Each child must be registered in the correct age group to participate. They must be of the correct age to participate on the day.

#### **Insurance Cover when Participating in HELL & BACK**

As every participant has different insurance needs, it is the decision and responsibility of each parent/guardian to ensure their children are fully covered in accordance with their specific requirements when participating in HELL & BACK Junior. Alive Outside, the organiser of the event, strongly recommends that each participant has their own Personal Accident Cover in case of injury.

#### **Infectious Diseases**

HELL & BACK Junior venues are often large, vast working farms, which are home to a wide variety of plants and animals, both domestic and wild. As the course involves running through trenches and boggy ground, Alive Outside encourages the guardians of all HELL & BACK Junior participants to be aware of the risks of Infectious Diseases, especially Weils / Leptospirosis Disease, which is an acute infectious disease spread by infected wild and domestic animals. If your child develops any symptoms after the event, you should see a medical professional immediately.

By accepting these Terms & Conditions, you agree to the risks associated with running through the natural habitat of these plants and animals.
