1. Parental/Guardian Declaration

By accepting these Terms & Conditions, I agree that Alive Outside is not liable for any personal injury or any other accident that may cause injury to me, my child(ren) or any of the children I am registering.

It is my responsibility to make sure other parents/guardians are fully aware of the risks associated with taking part, and to pass on any important information about the Kids Camp / HELL & BACK to them.

In case of injury or illness to me, my child(ren) or any of the children I am registering, I give my consent to emergency transportation and the administration of first aid and medical treatment.

2. Personal Accident Insurance Cover

As every participant has different insurance needs, it is the decision and responsibility of each parent/guardian to ensure their child is fully covered in accordance with their specific requirements when participating in the Kids Camp / HELL & BACK.

Alive Outside, the organisers of the event, strongly recommends that each parent/guardian has their own Personal Accident Cover in the unlikely event of their child getting injured.

3. Physical Condition of Participants

Alive Outside recommends that any parent who has health-related concerns about their child taking part in the Kids Camp / HELL & BACK, visit their local GP for a health check-up before participating in the event to make sure that the event is appropriate for them. All participants in the Kids Camp / HELL & BACK do so at their own risk.

4. Infectious Diseases

The Kids Camp / HELL & BACK take place in Killruddery Estate, a vast working farm, which is home to a wide variety of plants and animals, both domestic and wild.

Alive Outside encourages the parents/guardians of all participants to know the symptoms of Infectious Diseases, especially Weils / Leptospirosis Disease, which is an acute infectious disease spread by infected wild and domestic animals. If your child develop any symptoms, you should see a medical professional immediately.

By accepting these Terms & Conditions, you agree to the risks associated with your child running through the natural habitat of these plants and animals. Alive Outside does not accept liability for any illness contracted – everyone takes part at their own risk.

5a. Refunds – Kids Camps

Your registration is secured upon completion of the online purchase. As this purchase is for a Kids Camp for a specific week, unfortunately you are not entitled to a refund in case your child cannot attend. You may though be able to transfer to another week, subject to availability – see 7a. Transfers/Switching Events below for more info.

Unfortunately, the €20 deposit to secure your place in the Camp is non-refundable.

5b. Refunds – H&B

Your registration is secured upon completion of the online purchase. As this purchase is for a specific HELL & BACK event on a specific date, unfortunately you are not entitled to a refund in case you or your child cannot attend. You may be able though to transfer your registration to another person or move to another week/event (subject to availability) – see 6. Replacement Participants and 7. Transfers/Switching Events below for more info.

6. Replacement Participants – H&B

If your child(ren) cannot take part in HELL & BACK, you can easily appoint a replacement to take your place, right up to race day. Here is what to do:

1. Email the parent of your child's replacement your original Ticket / Confirmation Email.
2. On the day, your child's replacement should present this Confirmation Email to one of our marshals at the Registration Tent and collect your child's allocated Wristband on your behalf.
3. The parent of your child's replacement must read the Event Terms and Conditions and, if happy with them, print & sign their name beside the allocated Wristband Number - and draw a line through your child's name, indicating they are no longer participating.
4. So if your child can no longer take part, you can allocate your place to someone else right up until the event day.

7a. Switching Weeks – Kids Camps

Subject to availability, you may be able to switch your child's camp week by emailing info@aliveoutside.ie. Because many camps sell out in advance, the more time you can give us, the better chance we have of being able to accommodate you.

Unfortunately, if we are unable to accommodate your switch request, we will also be unable to refund your registration fee.

7b. Transfers / Switching Events – H&B

As well as transferring your registration to another person, you have the option to switch event dates. Requests to do so must be made in writing to info@aliveoutside.ie within the following time frame:

- Up to 6 weeks (30 working days) of Event = Transfer Possible
- Within 6 weeks (30 working days) of Event = Transfer Not Possible

Unfortunately, we will not be able to accommodate a transfer after this time. Switching dates is subject to availability and can only be done for events where registration is live on our website.

If you are unable to transfer to another event, you may be able to find a replacement to take your place. See 6. Replacement Participants section above for full details.

8. Event Rescheduling Policy

HELL & BACK events take place all year round and go ahead within the reasonable weather expectations of Ireland. As everyone is aware though, there is the potential for extreme or severe weather and therefore we have an Event Rescheduling Policy if the conditions are very bad.

Our aim is to do all we can to make your experience at HELL & BACK as enjoyable and safe as possible. If though we deem weather conditions to be potentially hazardous and unsafe for participants, we reserve the right to postpone and reschedule the event for an alternative date to maintain competitor safety.

Where possible, our policy is to postpone an event NO LATER THAN 9PM on the night beforehand and our decision about postponing an event is final.

In the case of a postponement, we will use all the media available to us to inform you as quickly as possible:

In the case of an event being postponed and rescheduled, you will have the option of:

1. Switching your registration to the new reschedule date; or
2. Getting a full refund*.

** To avail of a full refund, you must email info@aliveoutside.ie within **72 HOURS** of the rescheduled date being announced. Unfortunately we will be unable to offer you a refund if you do not contact us within this time.*

Alive Outside is not liable for any costs incurred by participants resulting from the postponement and rescheduling of an event, such as accommodation, transport etc.

9. Minimum Age Limit

Each child must be registered in the correct age group to participate. They must be of the correct age to participate on the day.

HELL & BACK is not suitable for children aged 4 or younger.

Alive Outside Kids Camps are not suitable for children aged 6 or younger.

10. H&B is not a Race, it's a Challenge!

HELL & BACK is a challenge rather than a race. The event is aimed at children from all sporting backgrounds and fitness levels. **Everyone** who finishes the course and makes it thru' Ireland's Toughest Physical & Mental Endurance Challenge for Kids is special in our eyes – not just the fastest! Therefore, we do not put any emphasis on the times children complete the course in.

Each child's focus should be on completing the course and doing their best but they should also be prepared to help their fellow participants throughout the route. Without a competitive element, this better encapsulates the ethos of what our event is about - focusing more on teamwork and helping each other, raising money for charity etc.

Your child's time, and who finishes first, is completely irrelevant to us but there will be a clock at the Start and Finish Lines showing the time of the day, so any parent who is interested in their child's time can calculate it themselves.

Placing more of an emphasis on helping fellow HellRaisers and camaraderie makes HELL & BACK a much better event for everyone and improves the experience of all our participants.

11. Optional Additional Costs

When you register a child for a HELL & BACK Event, the fee includes their entry into the event and an exclusive Finisher's Gift.

Unless otherwise stated, the following services are not included in the price but may be available for purchase separately:

It is the responsibility of each participant to complete HELL & BACK within the rules and regulations stated by Alive Outside. Anyone breaching these rules and regulations may be removed from the event without refund.
